Set for jury trial July 23<sup>rd</sup> in Department 6 before Judge Salter on misdemeanor charges of Driving Under the Influence (DUI) with a prior conviction for same. Trial vacated due to scheduling conflict. Case now scheduled for pretrial hearing on August 6<sup>th</sup> in Department 6.

**#1224443** Defendant Antonio Jose Moreno. Set for jury trial July 3<sup>rd</sup> in Department 4 before Judge Johnson on misdemeanor charges of Trespassing. Trial vacated when the defendant failed to appear.

**#1210848** Defendant Brent Eugene Kilpatrick. Set for jury trial July 10<sup>th</sup> in Department 2 before Judge Silveira on misdemeanor charges of Drunk Driving and Hit and Run. Trial vacated after the defendant pled no contest to Driving Under the Influence for 36 months informal probation, 7 days jail time, restitution, and specified terms and fines.

**#1218977** Defendant Jorge Lopez Nunez. Set for jury trial July 3<sup>rd</sup> in Department 4 before Judge Johnson on misdemeanor charges of Driving Under the Influence (DUI). Trial vacated after defendant pled no contest and was placed on 3 years informal probation, ordered to serve 5 days in county jail, and pay specified fines.

**#1218702** Defendant Luis Manuel Castillo. Set for jury trial July 10<sup>th</sup> in Department 2 before Judge Silveira on misdemeanor charges of Driving Under the Influence (DUI) while having prior convictions for DUI. Trial vacated after defendant pled guilty to DUI and Driving on a Suspended or Revoked license and admitted his prior DUI convictions.

**#1227629** Defendant Adam Wayne Goodman. Set for jury trial July 3<sup>rd</sup> in Department 4 before Judge Johnson on misdemeanor charges of Giving False Identification to a Peace Officer. Trial vacated after defendant pled guilty to the charge. He was ordered to serve 15 days in jail with credit for time served of 15 days. Defendant remains in custody on a parole hold by the California Department of Corrections.

**#1225143** Defendant Patti Jean Williams. Set for jury trial July 9<sup>th</sup> in Department 11 before Judge Salter on felony charges of Possession or Purchase of a Controlled Substance for Sale. Trial vacated when defendant pled guilty to Possession of a Controlled Substance and was placed on 36 months formal probation, ordered to serve 180 days in jail, and pay specified fines. Defendant received additional jail time for violating probation in two other cases.

**#1107876** Defendant Frank Daniel Fink. Set for jury trial July 9<sup>th</sup> in Department 11 before Judge Salter on felony charges of Auto Theft. Trial vacated due to a scheduling conflict. Hearing to reset jury trial scheduled for August 2<sup>nd</sup> in Department 11.

**#1220023** Defendant Heath Adam Villarreal. Set for jury trial July 9<sup>th</sup> in Department 9 before Judge Steffen on misdemeanor charges of Driving Under the Influence (DUI). Trial vacated after defendant failed to appear for a pretrial hearing. Jury trial reset for July 16<sup>th</sup> in Department 9.

**#1221452** Defendant Ezequiel Vigil, Jr. Set for jury trial July 9<sup>th</sup> in Department 9 before Judge Steffen on misdemeanor charges of Driving Under the Influence (DUI) with prior convictions. Trial vacated when defendant pled guilty and was placed on 3 years informal probation, ordered to serve 180 days county jail, and pay specified fines.
