#1226727 Defendant Timothy Floyd Smith. Set for jury trial August 28th in Department 3 before Judge Whiteside on felony charges of Robbery and Assault with a Deadly Weapon. Trial date vacated due to discovery issues and rescheduled for October 2nd in Department 3.

#1231183 Defendant Jake Steven Duncan. At a pretrial hearing held August 27th in Department 5 before Judge Zeff on misdemeanor charges of Driving on a Suspended or Revoked License and Having an Open Alcoholic Beverage Container or Marijuana in Vehicle, defendant pled guilty to Driving on a Suspended License. #1219356 Defendant Roy Edwin McElroy. Set for jury trial August 28th in Department 2 before Judge Silveira on misdemeanor charges of Domestic Battery. Trial date vacated after the Court granted the People's request to dismiss the case due to the victim being unavailable for trial.

#1217038 Defendant Craig Brent Nash. Set for jury trial August 28th in Department 7 before Judge Shaver on felony charges of Possession of a Controlled Substance. Trial date vacated after defendant pled guilty and was sentenced under California's "Proposition 36" statute to 36 months probation and ordered to participate in substance abuse counseling.

Trial date was vacated after defendant pled guilty to Driving Under the Influence (DUI), admitted the two enhancements, and pled no contest

He was then sentenced to serve two years in state prison for violating probation in # 1107909.

#1225697 Defendant Chanta Evon Brown. Set for jury trial September 24th in Department 5 before Judge Zeff on misdemeanor charges of Fighting in Public and Resisting Arrest. Trial date was vacated after defendant failed to appear at the pretrial hearing.

#1100070 Defendant Erick Wayne Brush. Set for jury trial August 28th in Department 4 before Judge Johnson on felony charges of Threats to Commit a Crime Resulting in Death or Great Bodily Injury. Trial vacated due to scheduling conflicts. The jury trial date will be reset on September 5th in Department 4.

#1221907 Defendant Ronda Lee Nelson. After a jury trial beginning August 28th and ending August 29th in Department 4 before Judge Johnson on felony charges of five counts of Making, Passing or Possessing a Fictitious Bill or Check and five counts of second degree burglary, the jury found the defendant guilty on all forgery counts, and guilty of the lesser included offense of Petty Theft on all of the Burglary counts. Defendant also admitted having been previously committed to state prison. Based on the conviction in this case, the court also found the defendant had violated probation in Case #1073243 which was for Receiving Stolen Property. The case was referred to the Probation Department for their investigation and report. Sentencing is set for October 11th in Department 4.

#1224345 Defendant Lorenzo Alfred Cardenas. Set for jury trial September 4th in Department 7 before Judge Shaver on misdemeanor charges of Petty Theft. Trial date vacated after the case was continued due to a scheduling conflict. Next court date is September 21st in Department 7 to set a new jury trial date.
