Modesto, California – Stanislaus County District Attorney Birgit Fladager announced today that Shane Valencia Thomas, age 22, of Modesto, was convicted on June 3, 2010 of possession of a stolen vehicle, auto burglary, auto theft, and resisting arrest. Thomas is currently on probation for possession of a firearm from January 2008. Deputy District Attorney Jeffrey W. Mangar prosecuted the case for the People.

On February 22, 2010 at approximately 2:30 p.m. in the area of Colorado Avenue in Modesto, Thomas was a passenger in a 1995 black Honda Civic that had been reported stolen on February 18, 2010 out of a parking lot at the Modesto Junior College while the victim was attending class. After performing a traffic stop, the officer observed that there was a shaved key in the ignition. Inside Thomas's pocket, the officer found another shaved key. Thomas stated that his friend picked him up in the car and that he knew the car was stolen but he wanted to ride in it anyway. After being arrested, Thomas posted bail for his release from custody.

On March 14, 2010 at approximately 9:00 a.m. in the area of Westmont Court in Modesto, an alert homeowner called the police after he observed Thomas prowling in his neighbor's backyard. After the police contacted Thomas, they found a car registration, Gummy Bears, and Valentine's Day candy in Thomas's pocket. These items were previously inside a parked car in the front of the neighbor's home. Thomas denied taking the items. After being arrested, Thomas posted bail for his release from custody.

On April 7, 2010 at approximately noon in the area of Briggs Avenue and Seybold Avenue in Modesto, officers from the Stanislaus County Auto-Theft Task Force (StanCATT) observed

Thomas driving a 1989 teal Toyota Camry that had been reported stolen on March 28, 2010 out of Modesto. The officers followed Thomas until he stopped and parked the car. When the officers attempted to contact Thomas outside the stolen vehicle, Thomas tried to run but was caught a short distance away.

Upon entry of the plea, the Honorable Scott Steffen sentenced Thomas to three years in state prison.
