One Suspect Arrested for 2013 Paso Robles Murder Three Other Suspects Still Being Sought by Law Enforcement

SAN LUIS OBISPO, CA, April 19, 2019 – On January 30, 2019, David Hernandez Rodriguez, previously of Stanislaus County, was arrested and extradited from Mexico to California to face charges for the 2013 murder of Victor Hugo Sanchez in Paso Robles and is now awaiting trial.

The San Luis Obispo County District Attorney's Office is asking for the public's assistance in locating ***Edgar Ontiveros, Louis Henry Madrigal, and Alejandro Benjamin Anguiano***, who are additional suspects in the murder of Victor Hugo Sanchez, which occurred on February 23, 2013 in the City of Paso Robles, County of San Luis Obispo.

Edgar Ontiveros, Louis Henry Madrigal, and Alejandro Benjamin Anguiano have active arrest warrants for murder and are considered armed and dangerous. Anyone with information as to the whereabouts of these suspects should contact their local law enforcement agency immediately.
